## **Freightflow.co Website Privacy Policy**

Progistix Worldwide, Inc. ("Company") recognizes the importance of protecting the privacy of information we may receive from visitors to our web site (this "Website"). You may visit our Website without telling us anything about yourself, and our Website only collects such technical information as disclosed in this Privacy Policy. If you do choose to provide personally identifiable information or other personal data, whether directly on the Website, in e-mail, text or other electronic messages, we may use it as described in this Privacy Policy. We do not collect or maintain personally identifiable information for resale purposes, or share your information with any other company or organization. By using our Website, you agree that this policy governs our collection, use and disclosure of any personal information submitted to us. If you do not agree to be bound by this policy, you may not access or use our Website. This policy does not apply to information collected by us offline or through any other means or by any third party.

### **Notification of Changes to This Policy**

Company is continually improving and adding new functionality and features to our Website and improving and adding to our existing product line, services and programs. Because of these ongoing changes, changes in the law and the changing nature of technology, Company data practices will change from time to time. If and when our data practices change, Company will post the changes on this page of our Website in order to notify you of such changes. These changes to the Privacy Policy will become effective when posted. Your continued use of the Website after we make changes is deemed to be acceptance of those changes. ### **Information We Collect About You**

We collect several types of information from and about users of our Website, including information:

- by which you may be personally identified, such as name, postal address, e-mail address, telephone number or any other identifier by which you may be contacted online or offline ("personal information"). Company will not collect any personal information about you unless you provide it to us. If you do not want your personally identifiable information collected, please do not submit it to us.
- about your internet connection, the equipment you use to access our Website, and usage details.

We collect this information:

- directly from you when you provide it to us.
- automatically as you navigate through the site. Information collected automatically may include usage details, IP addresses, and information collected through cookies, web beacons, and other tracking technologies.

The information you provide us may include:

- information that you provide by filling in forms on our Website. This includes information provided at the time of registering on our Website or requesting information through our Website, or using services or products on our Website, such as the FreightFlow platform. We may also ask you for information when you report a problem with our Website.
- records and copies of your correspondence (including e-mail addresses), if you contact us.
- your search queries on the Website.

Information we collect automatically may include:

- details of your visits to our Website, including communication data and the resources that you access and use on the Website.
- information about your computer and internet connection, including your IP address, operating system, and browser type.

### **Use of Personal Data Collected Through This Website**

We use information that we collect about you or that you provide to us, including any personal information:

- to present our Website and its contents to you in the most effective manner for you and your computer or mobile device.
- to provide you with information, products or services that you request from us.
- to contact you or allow our affiliates to contact you with offers of goods and services or information that may be of interest to you about supply chain sector services, materials, news or training. If we do so, each communication we send you will contain instructions permitting you to “opt-out” of receiving future communications.
- to allow you to access limited-entry areas of our Website as may be appropriate.
- to better understand your needs and how we can improve our products and services.
- in any other way we may describe when you provide the information.
- for any other purpose with your consent.

### **Disclosure of Your Personal Data**

Company may share some or all of the personal data collected through this Website with our affiliates, who will only use this data in accordance with this Privacy Policy. Both Company and our affiliates may share personal data collected through this Website with third-party vendors who act for or on behalf of Company or our affiliates, for example, companies that provide support services to us, including data processing services, or that help us market our products and services. These companies may need information about you in order to perform their functions. These companies are not authorized to use the information we share with them for any other purpose. In addition, there may be some other,

limited circumstances in which Company or our affiliates may share or transfer the personal data in our databases, for example, to comply with a legal requirement, to enforce the Terms and Conditions governing the use of this Website, to protect your interests, or in the event of a corporate sale, merger, reorganization, dissolution or similar event.

We may also disclose your personal information to comply with any court order, law or legal process, including to respond to any government or regulatory request, or to enforce or apply our Terms and Conditions and other agreements, including for billing and collection purposes.

Company does not sell, trade, or rent your personal data to others.

## **Security**

Company takes certain precautions to protect our users' information and to limit the risk that it will be accessed without authorization, including use of certain industry standard technologies and practices. We cannot, however, ensure or warrant the security of any information you transmit to Company, and you do so at your own risk. If Company learns of a security systems breach, then we may attempt to notify you electronically so that you can take appropriate protective steps. Company may post a notice on the Website if a security breach occurs. Depending on where you live, you may have a legal right to receive notice of a security breach in writing. ## **Cookies**

In order to collect certain anonymous data, Company may use temporary "cookies" that collect the first level domain name of the user (for example, if your email address is "fred@123.com," the cookie collects the "123.com" portion of your email address) and the date and time you accessed this Website. Cookies by themselves cannot be used to discover the identity of the user. A cookie is a small piece of information which is sent to your browser and stored on your computer's hard drive. Cookies keep track of non-personal information such as the URL that you came from and go to next, your navigation through the Website (for example, the advertisements that you click on), the browser and operating system that you use, and your IP address.
